The IJDRP is a peer-reviewed, open-access journal committed to the highest levels of credibility and integrity in scientific publishing, free from outside industry influence. Our mission is to create an internationally recognized journal that serves as the primary repository of scientific research documenting the role of nutrition and lifestyle in arresting and reversing chronic lifestyle-related diseases. 22,000 physicians subscribe.

Culinary RX - Powered by the Rouxbe Cooking School and The Plantrician Project, Culinary Rx is an online instructional cooking and nutrition education course that healthcare professionals prescribe to their patients for prevention and lifestyle health. More than 200 people participated during 2021.
